- Fundraising Strategy:

- Master Plan Phasing
 - Phase 1: \$4.2 M, washroom facilities, Deer Pen Rd, green initiatives, heritage building remediation, storm water management
 - Phase 2: animal pen upgrades, accessibility upgrades, First Nations exhibit, small playground, entry gates & signage
 - Phase 3: Additional upgrades, signage

- Master Plan Funding Status
 - Municipal, Provincial and Federal funding in Phases 1, 2 and 3.
 - Phase 0: Funded in progress
 - LP Building fully funded. 75% City of Toronto, 19% FHPZ, 5% Provincial.
 - Phase 1:
 - Doing Llama building this year; working on final permitting and tender process underway.
 - Deer Pen Road underway at 90%
 - Unfunded
 - Phase 2: Animal exhibit upgrades.
 - Phase 3: Accessibility upgrades, new animal pavilion.
 - Need \$3 million to complete
- Thank you to current partners: Honey and Griggs family foundations, City of Toronto, DTAH, GeoPro, etc.

• Report from the Treasurer:

- Generated \$80,000 of revenue
- Invested \$83,000 in capital improvements; our strategy has been to fund the soft costs
- Ended year with over \$523,000 of total assets
- 2017 Revenue: Llama Pen and blue boxes generated \$22,000; Honey match \$20,000; Scotia Marathon \$6,500, grant of \$7,500 from TD Friends of the Environment.
- 2017 Expenses
 - \$300,000 in soft costs: Phase 1 \$170,000; LP Building \$26,000. [CONFIRM \$]
- 2017 volunteer hours
 - Similar to 2016; 2006 hours for 2017

9. Scotiabank Marathon

- Won honourable mention; raised over \$6,500
- Oct. 21, 2018 is next race for this year.

10. Grants

- TD Friend of Enviro Foundation \$7,500
- Ontario Ministry of Tourism, Culture and Sport \$15,000
 - For soft costs only, for Phase 0; asked for \$19,000.
 - Will submit for Phase 1 for Deer Pen Road soft costs \$250,000.
- New Building Canada Fund: Prov and fed infrastructure; in progress; soft and hard costs. Ceiling of 50%. For Deer Pen Road.
- Cultural Spaces Fund: federal Min of Heritage; ceiling of 30%. For heritage log cabins.
- Tourism Development Fund: Phase 0: \$15,000 of funding secured, Phase 1: to be submitted later in 2018

11. Communications

• Capybaras: recap of media plan; 45,000 votes cast from all over the world; Alex, Geddy & Neil won. Media: CP24 Live Event, ABC Radio News, National Geographic Kids, BillBoard.com

- Website: visits to website peaked in June; made better effort to keep website updated; added social media feed to it.

- Visitor testimonials: gearing up for HPZ's 125th anniversary; asking people to share memories of HPZ online and at llama pen.

12. Master Plan Process

- Video played.
- Bring in another 140 trees; capture storm water and manage better; add services i.e. washrooms, classroom; reconfigure llama building.
- Phase 1 details almost finalized, and funding (ongoing). Progress from a time when City was going to close the Zoo, to now investing \$800,000 in the zoo.
- Process: at the Fundraising, and Phase & Implement stages. Working with province and federal government to maintain visibility; City has pass resolution that the HPZ is a priority project.
- Building funds: \$250,000
 - \$150,000 from Section 37; \$50,000 from Parks Capital; \$50,000 from FHPZ.
 - Cabins have to be raised 10 feet; fix rotting logs and concrete floor; return cabins. Adding heating for capybaras who live indoors in winter; washroom for zookeepers (found sewage pipes running under); building out a canopy.
 - Work will start Spring 2018.
